## Challenges

- **Calculating the costs of IT services.**

If you can't determine where costs come from, it's difficult for both business users and the IT organization to gauge the effects of structural or operational IT changes.

- **Inability to prove how IT assets and resources support the business.**

Many organizations lack the comprehensive view they need of hardware, applications, personnel, networks, external costs and telecommunications to pinpoint over- and under-utilization, true capacity and idle resources.

- **Lack of transparency.** To explain costs and demonstrate the business value of IT, you must be able to see the costs of servicing each separate business and show how this ties to service level agreements.

# How can IT control costs, align resources with operations and strategy, and justify IT chargebacks to business users?

## THE ISSUE

Analysts agree that ineffective IT and business alignment is the foremost challenge CIOs face when it comes to optimizing IT resources. Dealing effectively and efficiently with IT chargebacks through an IT resource management solution addresses part of the problem, because it manages resources, collects cost and usage information, and creates chargeback invoices. ### CASE STUDY: A large European bank

#### ■ Situation

When two large European banks merged, including IT assets and departments, they needed more detail and transparency into IT usage and costs per business unit than lump-sum cost allocations could provide. Yet the bank still wanted to give its business users straightforward, simple, fair and understandable information.

#### ■ Solution

The SAS solution made it more efficient and cost-effective for the bank to manage its combined mainframes, hundreds of midtier servers, and thousands of desktop and laptop PCs. The solution calculates and communicates resource usage by business unit and individual user, including the phone system and the data center.

#### ■ Result

The solution collects data about CPU usage, storage, printing and more. SAS processes this information, then provides reports for the IT department and the input that finance and control departments use to generate invoices. The monthly invoice shows information for 15 "products/services/cost objects" (such as CPU usage on the mainframe). These details show the bank exactly where each cost originated, making it easier to detect cost-saving opportunities.
